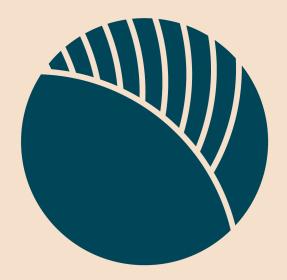

## Highlights – 2024-25 WA State Budget

The 2024-25 Budget provides cost of living relief for Western Australian families and invests in key services including housing and health.



\$762 million **cost of living relief** for WA households and support for small businesses



\$1.3 billion for education and training



\$1.1 billion **housing package** focused on boosting supply



\$3.2 billion investment in our health system



\$1.8 billion diversification and decarbonisation package



\$42.4 billion record infrastructure investment

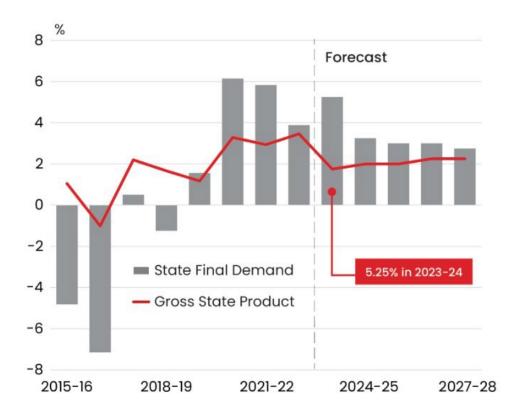


## WA Economy

- 5.25% domestic economic growth forecast for 2023-24.
- Strongest business investment in over a decade.
- Significant Government investment in infrastructure, expanding economic capacity.
- Western Australian household consumption resilient and the strongest in the nation.

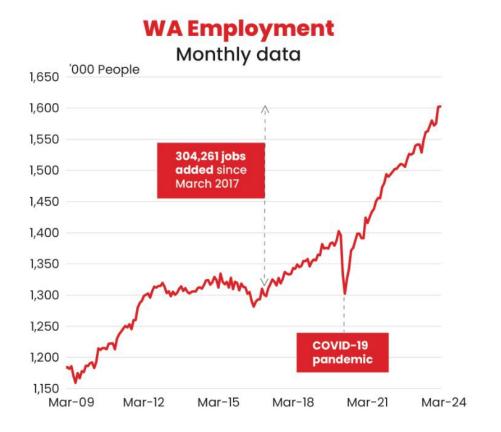

Western Australia



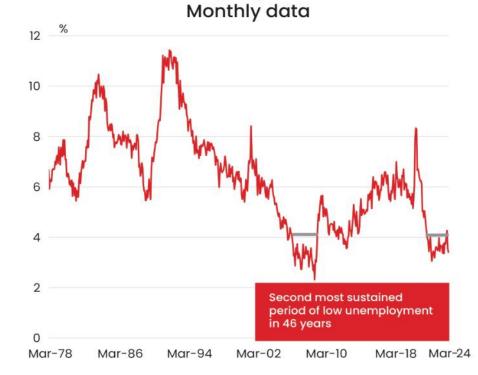
### Labour Market

Strong employment growth continues with more than 1.6 million Western Australians now employed, over 300,000 jobs added since 2017.



## Unemployment rate the lowest of the States and at historically low levels.

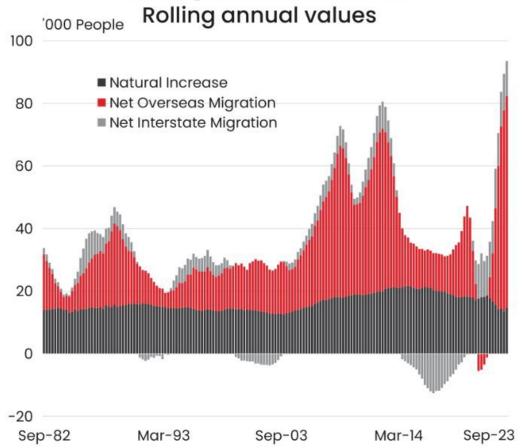




## **Population Growth**

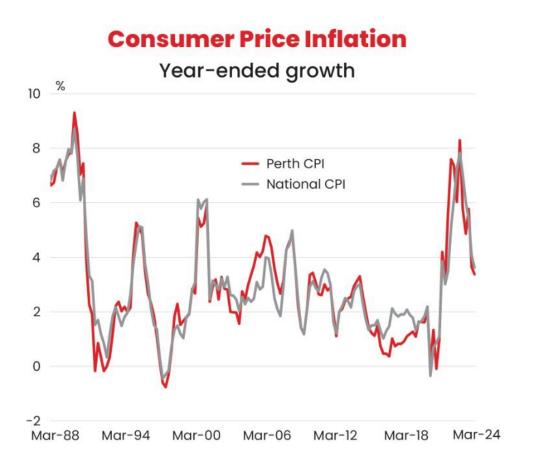
- Western Australia's population grew by 94,000 people over the year to September – the biggest increase on record.
- Population growth has been fuelled by strong net overseas migration nationally, as well as net interstate migration.
- WA's population is expected to exceed 3 million people next financial year.

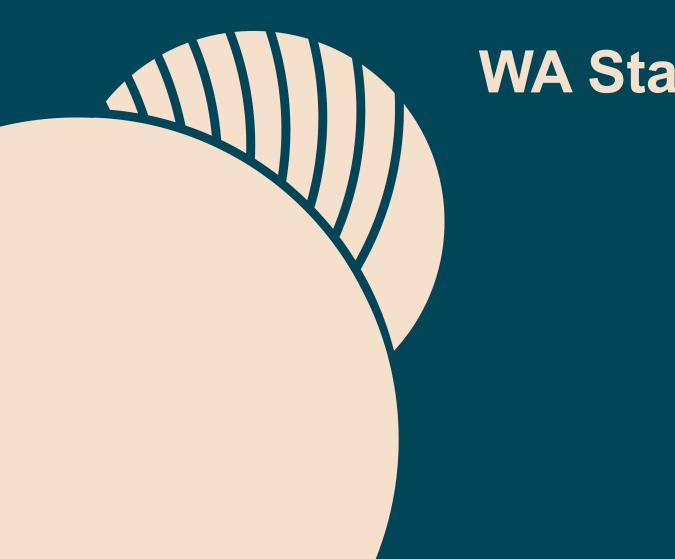
#### **WA Population Growth**



## Inflation

- Global inflation has eased from its peak in late 2022, but some pressures persist.
- WA CPI declined to 3.4% to March 2024:
  - Below 3.6% nationally.
  - Housing price pressures persist.
- Treasury forecast CPI to ease to 3% by mid-2025 and 2.5% by mid-2026.



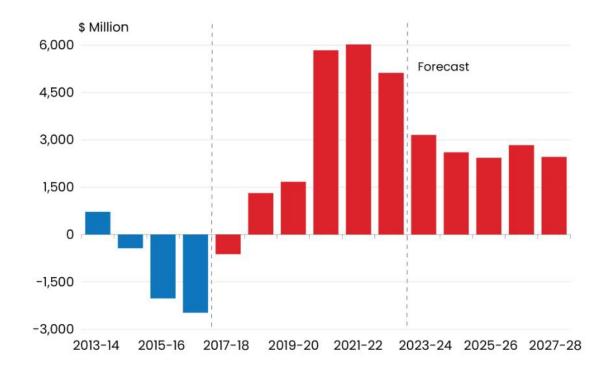


## WA State of the Finances

## **Net Operating Balance**

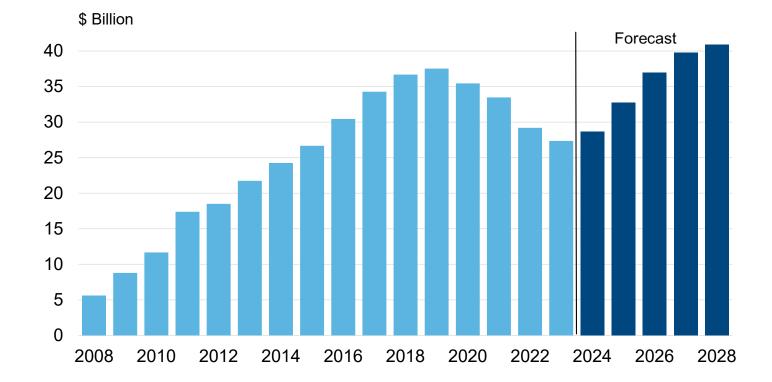
- Sixth consecutive operating surplus in 2023-24 of \$3.2 billion.
- \$2.6 billion surplus projected in 2024-25.
- Operating surpluses to be maintained across the forward estimates period.
- Strong financial position allows record investments in frontline services, cost of living support and infrastructure.

## **Net Debt**

- Forecast net debt of \$40 billion by the end of forward estimates
  - Balancing cost of capital works.
  - Conservative revenue forecasts.

# **Authorising Environment**

## **State Budget Process**

#### Timing is important – there is a short window between Budget decision-making cycles

#### Initiation Lead Agency and Minister

- 1. Prioritise and decide on portfolio initiatives:
  - Agencies and Ministers decide on priorities to meet Government's objectives
  - Includes cross-agency steering committees; engagement; community-led advocacy
- 2. Develop and lodge agency submission
  - Consultation with Treasury and other agencies
  - Ministerially-endorsed submission outlining proposed funding and resourcing

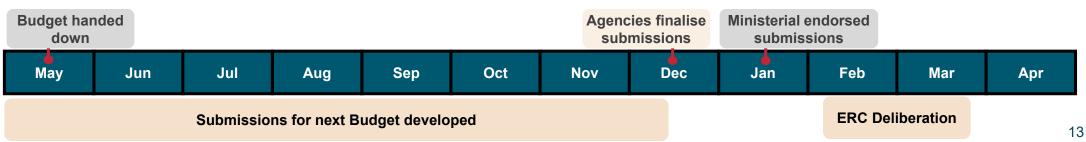
#### Consideration ERC

- 3. Treasury Analysis:
  - Informed by relevant agency and central agencies
  - Includes Treasury analysis of submission and recommendations
- 4. ERC consideration:
  - Minister's submission and Treasury minute
  - Prioritisation across whole of Government (resource allocation)

#### Authorisation Cabinet

- 5. Cabinet decision:
  - Considers and approves recommendations of ERC
- 6. Budget papers:
  - Publication of approved funding
- 7. Parliament Estimates Hearings:
  - Parliament scrutinises
     Government's Budget and passes
     supply for the Budget year

#### Typical timeframes (note this will be different in an election year)

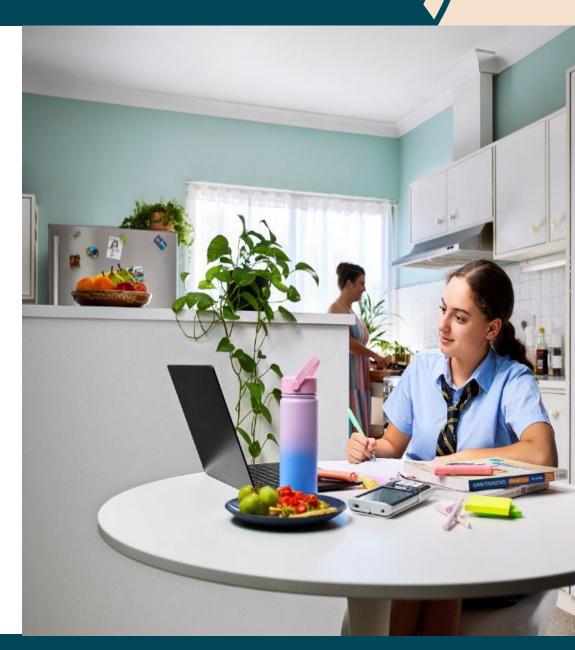


# Key Initiatves: 2024-25 State Budget

## **Supporting WA households**

\$762 million cost of living package delivering record support to Western Australian families:

- **\$400 electricity credit** for all WA households and small businesses.
- WA Student Assistance Payment providing up to \$250 per child.
- Free public transport for school students saving up to \$560 for a family with two kids.
- \$65 million to extend regional airfare caps.
- \$100 boost to the **Regional Pensioner Travel Card** to \$675 per year.



## Housing

- Massive \$1.1 billion additional investment to boost housing supply and affordability, and support homelessness services.
- \$400 million investment in the Social and Affordable Housing Investment Fund increasing total investment to \$1.6 billion.
- Almost 5,000 social houses committed in this term with more than 2,100 already delivered.
- \$179 million uplift to maintain the State's 45,000 social, remote and government worker houses.
- \$144 million in Housing Diversity Pipeline projects.



## **Stronger Communities**

- \$96 million for family and domestic violence initiatives and reform, bringing total new investment to \$422 million since 2021.
- \$88 million for child protection initiatives.
- \$70 million to implement reforms to improve fairness, advocacy and services for persons with mental impairment in the justice system.
- \$17 million to support historic overhaul of firearms laws.
- \$16 million for youth justice programs for Aboriginal and at-risk young people.



## **Supporting Community Services Sector**

Support for services contracted to the **non-government community services sector** include:

- \$44.3 million in Non-Government Human Services Sector (NGHSS) indexation updates.
- \$80.5 million for Health and Mental Health-related community service providers, including:
  - \$32.2 million to continue existing suicide prevention initiatives, of which \$18 million will go to community service providers.
- \$96.4 million to address and respond to FDV, including:
  - \$28.1 million to continue the FDV Response Teams (FDVRT) operating model, of which \$19 million will go to
    extending existing contracts delivered by community service providers.
- \$92.2 million to boost critical homelessness services delivered by the sector, including:
  - \$70.2 million increase in baseline funding for over 120 homelessness services providers.

**Almost \$300 million in further investments** focused on Closing the Gap and other initiatives which specifically or predominantly promote Aboriginal wellbeing, including:

- \$16 million for a range of youth justice programs, including the Therapeutic Approaches in the Children's Court of WA.
- \$12 million for the Aboriginal Social and Emotional Wellbeing Program.
- \$9 million for Jobs and Skills Centres Aboriginal Support funding, the Aboriginal Business Capability Building program, and financial counselling services delivered by ACCOs.
- \$6 million for Aboriginal Representative Organisation and Aboriginal Family Led Decision Making.
- \$3 million for the Aboriginal Community Connectors Program.

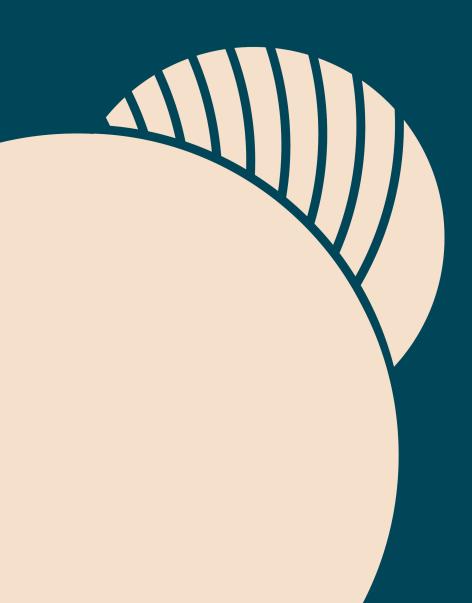
